#### **Homeowner's Dues**

Gaslite low annual maintenance fees are due on January 1<sup>st</sup> of each year. The first notice is sent in December of the prior year. A \$10 per month late fee is added each month thereafter, beginning in March. Your dues pays for maintenance on the entrances at Stony Brook and six Mile Lane, insurance, utilities, postage, newsletter, office supplies, banners, Christmas decorations, award money for Christmas display contest, legal fees, CPA fees and many other things.
